The resource person gave an outline on Income Tax and GST (Goods and Services Tax).He has stated the compliance of Income Tax, accuracy, efficiency and payment processes. The Government encouraged tax payers, thereby promoting compliance with tax laws and regulations. Further the process of tax filing for individuals and businesses, are made easy and simplified. Prompt submission of tax returns and payments within prescribed deadlines to avoid penalties and interest charges.
